Born in Scotland in the 2020s - Pilot Study

One Page Summary: Study Participant Information Sheet

Understanding how health and wellbeing in pregnancy and early childhood shapes our lives

Born in Scotland in the 2020s (BIS) is a study that aims to collect information from a group (a cohort) of pregnant mothers and their baby/babies during pregnancy and at birth. This type of study is called a birth cohort study.

We know from other birth cohort studies that the health and wellbeing of the mother during pregnancy can affect the health and wellbeing of the baby, both during development in the womb and whilst growing in childhood. In this study, we hope to collect information which will help medical professionals to give better care to pregnant mothers and babies, and make a positive difference to future families.

We intend to enrol 1,000 women into this small-scale pilot and use the findings to help us plan for and set up a much larger birth cohort study for the whole of Scotland.

If you are a pregnant woman (at any gestation) aged 16-50 years, living in the area served by **NHS Lothian** in Scotland and planning to give birth in Scotland then you are eligible to join this study. If you decide to join this study, we will use routinely collected data and biological samples (e.g. blood); you don't have to do anything extra to take part in the study. Your taking part will be confidential. Your data and samples will be stored anonymously, in secure facilities according to strict UK laws which safeguard your privacy at every stage.

How to Take Part:

If you join the study you can let us know whether we can contact you during your pregnancy to invite you to join additional optional studies e.g. we may ask if you would like to provide extra consent to collect some additional samples from you and/or your baby at the time of birth (such as a blood sample or placenta).
