

Research Round Up



STUDIES CURRENTLY RECRUITING.

Below are studies being promoted by ENRICH Scotland, so please have a read and contribute. Remember to put it in your CPD/Revalidation....it all counts.

SEARCH-U

This study is from Leeds University to find out what questions staff, residents and their relatives have about care homes, and which of these are most important. We want to hear from care home staff, people living in care homes, and their family members.

After piloting this survey, ENRICH Scotland staff have agreed that to get the best results we are happy to come to your home (where possible) and go over the survey with residents, staff or relatives. Please just get in touch with your local ENRICH CSO or Tay.ndntayside@nhs.scot

The DACHA Study.

Funded by the National Institute for Health and Care Research (NIHR) and sponsored by the University of Hertfordshire. We are looking for participants to take part in a consultation, individuals who have a relationship with older people's care homes in the UK, in their capacity as a care home staff member or manager, care home resident, primary care professional, commissioner/service provider, old age specialist (clinical/research), or a relative/family carer of a care home resident, are invited to participate in this 25-minute online survey: <https://app.onlinesurveys.jisc.ac.uk/s/herts/dacha>

DACHA research team have developed a care home *minimum data set* (MDS), which aims to improve the quality of information that staff collect about people living in care homes to support the care of residents. We would like to understand how useful and relevant the DACHA minimum data set is for people working in, for or with care homes, or for people who have a direct experience of care.

***Artificial Intelligence and Multimorbidity: Clustering in Individuals, Space and Clinical Context (AIM-CISC)**

The study aims to understand professional, patient and carers experience of health and social care for people with multiple long-term conditions and to identify better ways of organising care. The overall design combines qualitative analysis of individual interviews and focus group discussions with co-design workshops to develop two complex interventions for evaluation in a future study.

***Digital Nutritional Assessment Tool**

Malnutrition remains one of the most common challenges among older adults in the UK with over 35% of people in care homes affected by malnutrition. A team of researchers at Stirling University worked with older adults, care staff and dieticians and developed a food recognition tool that links photos of food to symptoms to help identify hazardous foods to decrease malnutrition risk. They are now looking for your feedback on the tool.

You can help in one of three ways:

- 1) Take 30 photos of a range of foods in your care home to help build a recognition database and earn up to £50 for doing so,
- 2) Fill out a short survey and be entered into a draw to win amazon vouchers- just scan the QR code,
- 3) If you are a care home manager, take part in a short interview and earn £30 for helping.

OPPORTUNITY TO SHARE YOUR VIEWS AND INFLUENCE THE DELIVERY OF PALLIATIVE CARE

The Scottish Government has asked Healthcare Improvement Scotland to gather the views of people about palliative care services. This will complement their own research in support of the development of a **new Palliative Care strategy** in 2023. The strategy will have 2 high level aims:

- Everyone in Scotland receives well-coordinated, timely and high-quality palliative care, care around death and bereavement support based on their needs and preferences, including support for families and carers.
- Scotland is a place where people and communities can come together to support each other, take action and talk openly about planning ahead, serious illness, dying, death, and bereavement. Between now and the end of February, our engagement will be carried out through group

discussions or one-to-one conversations either by phone, video or in person. We are particularly looking to speak with people who are from any of the groups noted below.

1. People living in remote, rural and island communities with health problems that mean they would be eligible for palliative care as patients or family members/carers,
2. Older people with multiple health problems, long-term conditions and/or general frailty,
3. Parents, children, and young people, and

We are delighted to announce that our next webinar is taking place on Thursday 29th February at 2pm. Dr Victoria Shepherd from Cardiff University is going to share her research on

CONSULT-ADVANCE Study: exploring the acceptability and feasibility of advance research planning

This will include:

- Older people, including those living in care homes, are encouraged to express their preferences about their future care and treatment should they be unable to communicate their wishes
- Other countries have extended these advance planning processes to enable people to also express their preferences for taking part in future research
- This might include making an advance research directive, as well as choosing who should be involved in future decisions about research participation
- We conducted a survey and qualitative interviews to explore views about the acceptability and feasibility of introducing advance research planning in the UK
- We found high levels of support for advance research planning, and identified a number of practical barriers with strategies to help overcome them
- Future activities will include developing tools and other resources to support its introduction in settings such as care homes
